A copy of a veterinarian's certificate for annual vaccination against Rabies, Distemper / Hepatitis, Parvo Virus and Bordatella (*please verify this requirement with your veterinarian*) must be enclosed or presented prior to commencement of the first class. All dogs must wear properly fitting training equipment, approved by the instructors. All dogs must be on lead (unless otherwise instructed) and under control at all times. It must also be understood that if in the opinion of the trainers, a person is unable to handle a dog, or if a dog or person presents a problem or hazard to the rest of the class, the handler must be replaced or the dog withdrawn from the class. **THE DECISION OF THE TRAINER IS FINAL.**
